The Supply and Delivery of Two (2) Modular Steel Bridges for the Ministry of Rural Development and Local Government.

The Ministry of Rural Development and Local Government (RDLG) hereby invites proposals for the Supply and Delivery of the following, under the Public Procurement and Disposal of Public Property Legislation:

1. TWO (2) MODULAR STEEL BRIDGES FOR THE MINISTRY OF RURAL DEVELOPMENT AND LOCAL GOVERNMENT.

Suitably qualified and experienced providers, listed in the Procurement Depository maintained by the Office of Procurement Regulation (OPR) shall be issued electronically the Invitation to Bid (ITB) documents, for the aforementioned tender.

The contract will be awarded in accordance with the pre-defined evaluation criteria and scoring system outlined in the bidding documents and shall be governed by the terms and conditions defined in the said documents.

- (ii) **Certificate of Compliance issued in accordance with the National Insurance Act (applicable to local firms).**
- (iii) **Company Profile.**
